From HR – Please Read: OSPI Certificate Expiration 6/30/19

As a certificated teacher or educational staff associate (ESA) with the Lake Washington School District, your employment requires that you hold a current teaching or ESA certificate. As such, you are responsible for maintaining the validity of your certification.

Information available on the Office of Superintendent of Public Instruction (OSPI) website indicates that your current certificate(s) will expire this coming **June 30, 2019**. Human Resources does NOT have record of this certificate being renewed as of today. If you have begun the reissuing/renewal process or your application is pending, please e-mail Human Resources confirming your status.

Send a copy of the new certificate via email to Human Resources by July 1, 2019, as the district is not automatically notified when certificates are renewed. Please also know that there is NO penalty from OSPI in renewing a certificate early!
