STEM Professional Development Requirement for Certificate Renewal From WEA:

Beginning on Sept. 1, 2019, many teacher certificate renewal applicants will need to document 15 clock hours, or one goal from a Professional Growth Plan, in Science, Technology, Engineering, and Math (STEM) professional development. This professional development must integrate at least two out of the four STEM elements. Teacher certificate holders who are endorsed in one or more of the endorsement areas listed below and are renewing after Sept. 1, 2019 must meet the STEM requirement.

Teachers with June 30, 2020 certificate lapse dates and beyond need to have completed this requirement prior to applying for renewal. (Note: Teachers with June 30, 2020 lapse dates can apply for their certificate renewal between July 1 and Aug. 30 of 2019 without needing to document the STEM requirement.) NBCTs who maintain a valid National Board Certificate can use that for certificate renewal, and do not need to complete this STEM requirement.

Who needs to complete this requirement? Teachers with residency, professional, initial or continuing certificates who have endorsements in any of the following areas:

- Computer Science
- CTE (All Areas)
- Designated Sciences: Biology, Chemistry, Earth & Space Science; Physics
- Early Childhood Education
- Elementary Education
- Mathematics; Middle Level Mathematics
- Science; Middle Level Science

ActivInspire and ActivBoard

Will be Leaving the Classroom

Over the past two years, Technology Operations and Technology Integration have communicated that ActivInspire software had reached end of life and was no longer fully supported by Promethean. Due to licensing agreements, ActivInspire and ActivBoard drivers will be removed from teacher devices as of June 30, 2019. This means that ActivInspire flipcharts will no longer function on LWSD devices.

Teachers who wish to access information in existing flipcharts will need to convert files to OneNote, PowerPoint, etc. by June 30, 2019. Instructions are posted on <u>KIT</u>.

SMART Notebook, a software program designed to create interactive, dynamic lessons is currently available on all elementary teacher devices and was pushed out to secondary teacher devices in January 2019. If teachers did not see SMART Notebook, they need to submit a HELPDESK ticket.

Professional Learning specific to SMART Notebook will be provided to secondary schools during the ActivBoard replacement process. Instructions for building lessons within SMART Notebook are posted on KIT.


