



With 28 days until SEBB Enrollment Closes, approximately 1700 employees have created a login and approximately 1800 have not....why wait? Create your account NOW.

This does not mean that all 1700 employees have made their benefit elections. Approximately 1000 out of the 1700 still have the default benefit plans. This means only to 20% of employees have completed their elections. To set up an account go to myaccount.hca.wa.gov

### SEBB: Make A Choice or One Will Be Made For You

If you do not enroll, you will be **defaulted** as a single subscriber into:

- Uniform Medical Plan (UMP) Achieve 1 (\$33 monthly premium)
- Uniform Dental Plan
- Metlife Vision Plan
- Basic Life Insurance
- Basic Accidental Death and Dismemberment (AD&D) Insurance
- Basic Long Term Disability (LTD) Insurance

### In addition:

- Your dependents will not be enrolled.
- You will be defaulted as a tobacco user with a \$25/month surcharge.
- The next opportunity to make any changes will be during open enrollment, next year.

If you do not want medical coverage, you <u>must</u> actively opt-out to **WAIVE** medical benefits to avoid being defaulted into a plan with a monthly premium.

## **Are You a Nursing Mother?**

LWEA and LWSD have collaborated to comply with and clarify the processes for the new rules regarding breast feeding in the workplace. The new state law, House Bill 1930, "Expression of Breast Milk in the Workplace – Reasonable Accommodation", provides nursing parents the necessary accommodations. The law requires the employer to provide:

- i. Reasonable break time to express breast milk for two years after the child's birth each time the employee has need to express the milk.
- ii. The employee will be provided a private location, other than a bathroom, if such location exists at the worksite.
- iii. If the worksite does not have a convenient location, the supervisor will work with the employee to identify a convenient location and schedule to accommodate their needs.

**To request this accommodation**: Employees are responsible for making the request for these accommodations to their administrator/supervisor.

**To receive these accommodations**: Administrator/supervisor will work to meet the above conditions within a reasonable timeline of the employee's request.
