COME PREPARED:

- Have your SEBB account set-up
- Research your options and come with specific questions
- Bring your Dependent Verification (DV) documents [Allowable DV Documents](#)

To set up an account go to myaccount.hca.wa.gov

HELPFUL HINTS:

1. You do not have to complete your enrollment all at once.
2. You can work in small increments (15 minutes at a time)
3. You can **make changes to your account anytime** through Nov. 15

SEBB: Make A Choice or One Will Be Made For You

If you do not enroll, you will be **defaulted** as a single subscriber into:

- Uniform Medical Plan (UMP) Achieve 1 (**\$33 monthly premium**)
- Uniform Dental Plan
- Metlife Vision Plan
- Basic Life Insurance
- Basic Accidental Death and Dismemberment (AD&D) Insurance
- Basic Long Term Disability (LTD) Insurance

In addition:

- Your **dependents will not be enrolled.**
- You will be defaulted as a tobacco user with a **\$25/month surcharge.**
- The next opportunity to make any changes will be during open enrollment, **next year.**

Waive Your Medical Benefits?..... Want to Continue to Waive?

If you do not want medical coverage under SEBB, **you must actively opt-out to WAIVE medical benefits** to avoid being defaulted into a plan with a monthly premium.
