# **Changes Are Coming to the Update!**

LWEA has historically used district email to communicate our Update. However, we face new challenges as an association and must evolve to meet those challenges. We will be moving our Update off LWSD email addresses and into more private communication.

#### Why the change?

- Public records requests from the Freedom Foundation, which actively work against our student and teacher interests, mean we need to be able to communicate with more privacy.
- All emails we send via school email are subject to public records request, and we want the ability to have private communications with our members.
- · Most large education associations (like LWEA) have moved to a more efficient and private system of communication; our goal is to modernize our communications by following their example.
- We still maintain our trust agreement with LWSD and continue to collaborate and work with LWSD on issues that are of concern to our members. The reasoning for this transition has nothing to do with LWSD.

Can I still use my LWSD account for union communication? Yes you can.

We are encouraging people to use their home email if they would like to ensure that the communication is private and not subject to a records request.




