A Message From LWEA President Howard Mawhinney

A blue sky and 70-degree forecast have made another week at home a little easier to accept. Despite the good weather, the challenge to stay home is more difficult with each passing day.

Even more than my desire to visit Kopachuck state park at low tide or hike the Kendall Katwalk, I really would enjoy simply returning to something that resembles a regular schedule, interaction with the LWEA staff, building visits, and rep meetings. And most of all, I am grateful to have a career that allows me to do what I love and people to ensure that I get paid for doing what I love. These constants from LWEA and my union reps have helped tremendously during this COVID-19 closure."

As a family we have experience teaching in areas with less union protections and saw the impact not just on pay but on the quality of life that comes from being valued as a professional. Submitting Professional Fund Documentation

Deadline to submit Professional Fund receipts is June 1, 2020. **Don't wait – begin gathering your documentation and submit now.** Please bring your reimbursement form and receipts to your school office for delivery to the Accounting Dept. at the Resource Center (inter-district mail is picked up at schools each Wednesday) or by US mail to LWSD Accounting Dept., PO Box 97039, Redmond WA, 98073-9739. No electronic copies will be accepted. Original receipts for purchases must be submitted. The reimbursement form can be found here, on the budget page of the staff portal. Most of your questions can be answered by reading the instructions on the reimbursement form. If after review you still have questions, please send to askprofessionalfund@lwsd.org. Eligibility questions should go to Tyler Harris, Tyharris@lwsd.org. Please do not contact accounting to confirm your packet was received. Accounting will contact you with any questions.

Due to the rising of coronavirus phishing attacks and hacking campaigns, you are encouraged to remain vigilant for the coronavirus phishing emails posing as **CDC** and **WHO** in an effort to steal your sensitive information. Carefully follow the guidelines below in order to protect yourself from being a victim of the coronavirus phishing email scams.

- Do not open attachments or click links within emails from senders you don't recognize.
- Do not provide your username, password, date of birth, social security number, financial data, or other personal information in response to an email or robocall.
- Always verify the web address of legitimate websites and manually type them into your browser.
- Check for misspellings or wrong domains within a link (for example, an address that should end in a .gov ends in .com instead).



Have you ever noticed how you breathe when you feel relaxed? The next time you are relaxed, take a moment to notice how your body feels. Or think about how you breathe when you first wake up in the morning or just before you fall asleep. Breathing exercises can help you relax, because they make your body feel like it does when you are already relaxed.

Deep breathing is one of the best ways to lower stress in the body. This is because when you breathe deeply, it sends a message to your brain to calm down and relax. The brain then sends this message to your body. Those things that happen when you are stressed, such as increased heart rate, fast breathing, and high blood pressure, all decrease as you breathe deeply to relax.

- The way you breathe affects your whole body. Breathing exercises are a good way to relax, reduce tension, and relieve stress.
- Breathing exercises are easy to learn. You can do them whenever you want, and you don't need any special tools or equipment to do them.
- You can do different exercises to see which work best for you.
