**De-escalation Strategies for Practicing Educators** 

Designed to empower para-educators and school staff to address student agitation and escalating behavior and to calm and refocus the behavior back to student learning and time on task. Teaches educators to understand that behavior is a form of communication and as a result, identify the aspects of escalating behavior, address the escalation, and select the correct response options. Provides practical strategies, ideas, resources, and tools to better engage with students during times of escalation. It is specifically designed for both education support personnel and certificated staff, basically anyone that works with students in a school setting. **4 CLOCK HOURS**

### **TPEP 101**

Teacher evaluation is mandated in law and rules through RCWs (the law) and WACs (the rules). Much of the process is determined at the local level. Teacher evaluation is bargained and agreed upon between the local association and the district. As a result, we have lots of similarities in the 295 districts across the state but we also have many differences. Evaluation in local districts have different instructional frameworks, different processes, different expectations, different evidence and artifact requirements, different plans of improvement, different procedures for student growth, different component level scoring and different philosophies. This training highlights much of the RCW and WAC components of evaluation but the nuances will be found in your local contract. **4 CLOCK HOURS**
