 - a. Labor Management
 - i. Displacements -
 - 1. All but three have been placed in positions.
 - 2. Staff cannot displace into "comprehensive schools" or into "RIZ schools"
 - ii. Nominations and Elections
 - Mary Jo recommends that there is a representative from the executive board on the Nominations and Elections Committee. Bradley recommends that we have two exec board members who are not elected in the same calendar year as representatives on the N&E committee.

iii. Evaluation

- 1. District has committed to providing additional training for administrators. Is also looking into what it would cost to hire Susan Ormbrek to provide some training. They are also hiring a .5 position to cover evaluation and the BEST mentor program.
- iv. ATP student situation
 - 1. Mary Jo described a concern with a student with additional needs in ATP who is creating an unsafe working environment for staff. Contract requires a safe working environment for staff.
 - 2. District is requiring staff to take a course on Canvas prior to approving 1:1 aides. REA is looking into the legality of this requirement.
- v. Two potential new grievances
 - 1. Sick leave monitoring
 - a. inappropriate discipline for use of sick leave
 - 2. Employee submitted evidence in evaluations.
 - a. administrator refused to admit any evidence entered into evaluation by staff member.
 - 3. Grievance filed by member at Renton Park (On her own- checking on progress and timeline. She may be filing a second one on an act of racism against her during a meeting.)
 - a. Member is filing a grievance due to administrator's response to her explanation of what staff member feels was a cultural misunderstanding.
 - 4. Julianna asked about the possibility of training by Annie Lamberto(?) on what other districts are doing about rights for SpEd staff.
