On Dec. 9, WEA-Retired presented a virtual "Pensions, Legislation, and Collective Action Talk."

We will have a virtual "Lobby Week" with WEA-Retired & RPEC (Retired Public Employees Council) members on Jan. 31- Feb. 4. The President's Corner

This is always the time of the year when we reflect on what has happened during the last year and look forward to the year ahead.

During 2021, we started off the year by virtually having "Our Largest WEA-Retired Lunch Ever" with professional chef, Madeleine Smithberg (Mad in the Kitchen). We even invited her back in May to have another lunch where we also invited new retirees who had not yet joined us. We received a lot of positive feedback, as members enjoyed cooking with her and seeing each other on Zoom.

In January 2021, we had our first virtual Lobby Week with our union siblings, Retired Public Employees Council (RPEC). We had a joint legislative training session as

well as virtual meetings with our legislators. Seventy members signed up to attend, which was almost double from the previous year, because the virtual format made it easier to participate.

In March, we acknowledged our first full year in a global pandemic. The annual March NEA Leadership Summit & the NEA-Retired Conference became a virtual event. Twenty-three of our members participated instead of the usual two, as was our custom due to the cost of flights and lodging.

In April, we attended an expanded virtual WEA Representative Assembly that once again included New Business Items (NBIs). We had more than 40 WEA-Retired delegates, which was about a 25 percent increase in participation.

In June, we had our second virtual WEA-Retired Annual Meeting with delegates from each chapter. In June & July, we had an expanded virtual NEA Representative Assembly & NEA-Retired Annual Meeting. Our delegate allocation is seven WEA-Retired delegates. At the state level, WEA-Retired has ongoing working committees, teams, and affiliate representatives.

- The Legislative Work Team meets monthly, consisting of 17 members working for you.
- The Membership Committee meets monthly to discuss membership engagement & recruitment.
- The WEA-Retired Board has 22 board directors, one for each UniServ Council area.
- The WEA-Retired Board also includes our officers, committee chairs, and affiliate reps.
- We have WEA-Retired representatives on the Washington State Alliance for Retired Americans (WSARA), Senior Citizen Lobby, and the WEA-Retired Scholarship Boards.
- Other active committees include: Audit, WEA-Retired Awards, and Nominations/Elections.
- The WEA-Retired Pre-Retirement Seminars' program has committee members and over 40 trained seminar presenters.

• WEA-Retired has members serving on NEA-Retired committees: NEA-PAC, communications, membership, and legislative.

Connecting with our allies: WSARA & Senior Lobby

Washington State Alliance for Retired Americans WSARA fall conference highlights

The Washington State Alliance for Retired Americans (WSARA), a statewide nonprofit organization with over 90,000 members, educates the membership, the public, and elected officials about the issues that affect the well-being of Washington's senior citizens. WEA-Retired is a member of WSARA; Mary Lindsey is a vice-president and Shirley Hickey serves as secretary on WSARA's executive board. The 2021 WSARA Convention and 20th Anniversary Celebration of fighting for retirement security was held this year on Oct. 5. Twelve WEA-Retired members attended the virtual meeting.

Larry Brown, president of the Washington State Labor Council (WSLC), highlighted key issues for the upcoming 2022 legislative session. Legislation includes overtime pay for farm workers in Washington, high earners paying some tax through capital gains, health care transparency, labor standards to protect healthcare workers, those working for a living being paid at least minimum wage, the prohibition of building any new private detention centers, protection for whistle blowers, and the passing of police reform bills.

Rich Fiesta, Executive Director at the Alliance for Retired Americans, is an expert in retirement security issues, including Social Security, Medicare, pensions and health care. He spoke about the American Rescue Plan.

Dr. Kim Schrier, representative from the 8th Congressional District, received the WSARA Hero Award for her dedication to representing seniors and retirees in Congress. She recounted senior issues near and dear to her heart, including the Build Back Better Bill to reduce high drug costs and, with a rise in scamming, a bill to cut down on robocalls. She also has proposed the Medicare Vision Bill which would expand vision coverage for seniors and include hearing and dental coverage as well.

The Convention ended with a review of the 20-year history of WSARA and its desire to connect retirees back to their unions. WSARA continues to work on growing the organization.

Senior Citizens' Foundation 2021 virtual fall conference By Phyllis Farrell, WEA-Retired Chinook

The Washington State Senior Citizens Lobby is a coalition of 37 public service groups, government agencies, and nonprofit and private groups striving to advocate on senior issues. The Senior Lobby has been in existence since 1977. WEA-Retired has member representation, and I represent WEA-Retired as one of the seven members on the Board of Directors.

This fall conference was a virtual, one-day meeting on Oct. 21. There were 208 participants registered. Three WEA-retired members attended this year.
