Washington State Labor Council (WSLC) Legislative Conference By Shirley Hickey, WEA-Retired Vice President & WSARA Secretary

Several WEA-Retired members, as affiliate members of the Washington State Alliance of Retired Americans (WSARA), attended the virtual Washington State Labor Council (WSLC) / AFL-CIO Legislative Conference and Lobby Day on Jan. 28. Union leaders, union members, and pro-union elected officials kicked off the event with a series of rapid-fire presentations about the status of worker conditions and target goals for addressing them.

Representative Liz Berry from the 36th LD and House Labor Committee noted the extreme healthcare staffing shortage. WSLC Legislative Director, Sybill Hyppolite, reported on bills concerning apprenticeship training combining classroom, on-the-job training and course credit. The space industry supports a three-part platform for building IT, state agencies, and sustainability of a pathway to union jobs to raise employment outcomes. As with most political initiatives, there is push and pull tension. One example is that healthcare labor staffing goals are opposed by the Hospital Association administration. An International Brotherhood of Electrical Workers (IBEW) member, Matthew Hepner, noted that journey level electrical labor union jobs went to the Bay area of California and to right-to-work states where it is easier to do the permitting process. Factors that may need to be addressed include the Clean Energy Act, the State Protections Act, energy council storage, job pathway options, and job opportunities.

After hearing from additional speakers, attendees heard the same briefing as WEA and WEA-Retired member lobbyists hear: Get to know priority bills, share your name and area you live in, use your voice and your story to share what matters, and do the "ask."

The President's Corner

If you are receiving this *Connections*, you are a member of WEA/NEA-Retired. Some of you joined very recently, and some of you have been members for decades. Thank you for being a member! We need your help with increasing our membership. Please encourage your friends and colleagues to join as a WEA/NEA-Retired member or pre-retired member! Joining in April can save them even more money as a life member and lock their dues to the 2022 prices.

During the month of April only, we will be offering a \$50 rebate to WEA members who join as a pre-retired life member. We are the only retiree group that offers a life membership. For WEA certificated staff, the life membership is \$550 before the rebate. For WEA ESP staff, life membership is \$430 before the rebate. (Payment plans are available.) If you are a

WEA ESP staff, life membership is \$430 before the rebate. (Payment plans are available.) If you are a current member of WEA Fourth Corner or Kent UniServs, they are matching the WEA-Retired \$50 rebate for a total of \$100 rebate (at the time of this printing) for their members!

During April, we will also be offering a \$50 rebate to WEA members who retired (or severed employment) without joining WEA/NEA-Retired as a life member. Sometimes people do not realize that members need to officially join WEA-Retired, so this is their opportunity to join at a reduced rate.

Like any other organization, the more members we have, the larger the impact. We work hard with our allies and have made progress this legislative session with another 3% cost-of-living adjustment (COLA) for TRS and PERS Plan 1, this time up to \$110 a month. Of course, we need to make this an annual COLA like Plans 2 and 3. A true COLA like Social Security is a goal. We also got the hours increased for retirees going back to work without impacting their monthly pension payments. Are we finished yet? No, a lot of work still needs to be done. Together we can improve our retirement security for current and future retirees, especially in the areas of pensions and healthcare.

Join us on May 4 for a Virtual WEA-Retired Symposium: Pensions, Legislation and Next Steps from 10 to noon. You will receive an update on what we accomplished during the 2022 session and next steps for the 2023 legislative session. It is not too early for us to plan ahead.

- On even-numbered calendar years, we elect our secretary and half of our WEA-Retired Board Directors.
- Every year we nominate delegates to represent chapters/councils throughout the state.
- All nominees must be WEA-Retired members and not currently under contract with a public school district.
- You may nominate yourself and/or another retired member. If you nominate someone other than yourself, you must have the consent of the nominee.

At the start of my virtual 47th LD lobby breakout session, I met my two teammates, Jeremy, a member of the Amalgamated Transit Union, and Misha, a member of the Office and Professional Employees International Union. Jeremy drives a King County bus and is concerned about finding support for solutions for the working and safety conditions for drivers and passengers due to alarmingly increasing numbers of riders refusing to pay fares and using massive quantities of drugs. Misha works in a medical provider union partnership department office and said that she was unsure of doing her first ever lobby day, but she ended up speaking expertly about healthcare access and staffing needs. As a WSARA representative and retired educator, I stayed on the WSLC priority issues. I highlighted the need for staffing standards, breaks for workers, and support for learnwhile-you-earn apprenticeship programs.

Remembering Jean Savidge

In June of 1983, NEA-Retired held its first annual meeting in Philadelphia. Two delegates from Washington, Gail Kirk and Jean Savidge, attended at their own expense.

These two women had an idea: create an organization in Washington state for retired educators to continue serving students and staff in public education. Working with former WEA Presidents Reese Lindquist and Terry Bergeson and former WEA Executive Director Jim Seibert, WEA-Retired held its first meeting in June 1987. During her lifetime of service, Jean served as WEA-Retired president, vice president, board director and editor of the WEA-Retired News.

In 1993, she and Lee Gillam started the WEA-Retired pre-retirement seminar program, "Taking Charge of Your Future." This program grew from five seminars during the first year to more than 50 seminars today.

In 1994, she was selected as the WEA-Retired Member of the Year for her contributions to the organization. In 2014, she received the NEA-Retired Distinguished Service award in special recognition of her extraordinary support of NEA-Retired's ongoing advocacy work.

Perhaps Jean's biggest legacy was her encouragement of involvement. She recruited people her entire life to join the organization, to take a leadership position, to become a seminar presenter. And once she got you involved, she did not walk away. She made sure you succeeded.

Remembering Jean Savidge

Jean Savidge was a founder of WEA-Retired and remained very active throughout her 80s as a member of the WEA-Retired Legislative Work Team, lobbying in Olympia, attending WEA Fourth Corner meetings and participating in pre-retirement seminar trainings. Jean was also a regular attendee at the WEA Representative Assemblies as a delegate, and she staffed the WEA-Retired table to answer questions and encourage other delegates to join WEA-Retired.

Jean Savidge started teaching in 1950 in Richland at a salary of \$1,700 a year. During her teaching career, she also taught in Bellevue, Yakima, Westport, Cheney and Portland. She retired from the Hoquiam School District in 1982. Her retirement was short lived, as she moved on to Grays Harbor Community College to teach reading.

I did not meet Jean until about 2010 when she and her husband, Jim, moved to Blaine. After having been involved in the WEA Chinook chapter, as well as WEA-Retired and NEA-Retired, she wanted to get involved in WEA-Retired Fourth Corner activities. And get involved she did. Throughout her 80s, she taught retirement sessions on healthcare and the state retirement plans and helped organize trainings. We worked as a team to provide active WEA members with the information they needed to transition to their retirement years. She often said that when she first started the pre-retirement seminars, she wanted to make that transition easier for those who followed her. She was an expert on our state retirement system and healthcare. She knew the answer to any question asked of her. When a member needed someone to talk to about retirement issues, I would always call her. She was always willing to get in touch with the member to assist them.

She was the person who got me involved in the Washington State Alliance for Retired Americans (WSARA). At the time, she served on the WSARA board and wanted to step down. Before I knew it, I was replacing her on the board, and I have never regretted it. It is a strong group made up of many union members and organizations. It makes sense, as she was a strong woman who worked on behalf of union members and organizations.

Jean Savidge would have celebrated her 92nd birthday in March 2022. She passed away in fall of 2021. She leaves behind her husband of 39 years, Jim; a son; a stepdaughter; two granddaughters; four step-grandchildren; and a combination of seven great-grandchildren. For those wishing to do so, Jim suggested that donating to the WEA Children's Fund would be a wonderful way to honor Jean's legacy.
