### 22-23 Covid Leave Provisions

LWSD and LWEA have a shared interest in protecting members from entering a negative leave balance due to Covid isolation requirements. When someone runs out of leave, they enter unpaid status and risk of losing their benefits. Over the last few years, a majority of members have grown their leave balances (both sick + annual), and these larger leave balances present a financial liability to LWSD.

However, in order to meet the shared interest of protecting members from negative leave balances due to Covid isolation requirements, LWEA and LWSD have come to an agreement that:

- No member will enter an unpaid status due to required Covid isolation during the 2022-23 SY.
- LWEA and LWSD will regularly review low leave balances (5 days or less of sick+annual leave) of members.
- Any member who would enter unpaid status due to Covid isolation requirements will be made whole in accordance with required isolation days, even if the required isolation period was in semester 1.

### FSA Carryover and "Use It or Lose It"

#### What is carryover and "Use it or lose it"



If you have not spent all the funds in your FSA by December 31 – and you are still employed and didn't lose eligibility for the FSA – you may be able to take advantage of the carryover feature, where certain unspent funds may "carry over" into the following year without affecting annual maximums.

To carryover your unspent funds:

- You must enroll in either the Medical FSA or Limited Purpose FSA for the following year, or
- Have at least \$120 left in your FSA balance.

For funds carrying over from 2022 to 2023, any amount above \$570 or below \$120 remaining in your account on December 31 will be forfeited to the plan administrator, the Health Care Authority. This is referred to as "use it or lose it."

#### Claim submission deadline:

You must submit all claims to Navia Benefit Solutions for reimbursement by March 31, 2023. If you are no longer employed or have retired and still have money left in your account, you can still submit claims for reimbursement by March 31, so long as the services took place while you were employed.
