Important Deadlines are Approaching

Certificate Renewal Applications submitted beginning July 1, 2023:

New Equity Requirement

In 2022, the Professional Educator Standards Board (PESB) approved new Cultural Competency, Diversity, Equity & Inclusion (CCDEI) standards. The CCDEI standards provide the foundation for the new equity certificate renewal requirement.

- As part of the 100 clock hours for certificate renewal, teachers must complete 15 clock hours, or the equivalent in credits or PGPs, in equity-based school practices.
- Teachers who maintain a valid NBPTS National Board certificate can meet the equity certificate requirement.

Important Dates for Certs Retiring This Year

Understand the importance of and implications of your retirement date. Things to consider:

- Benefits end the same month that you retire.
- You receive a full service credit with DRS if you complete your contract regardless of the date you retire.
- If an employee separates from service June 30th –
 Retirement date is 7/1 and SEBB benefits stop on June 30th
- If an employee separates service August 5th- Retirement date is 9/1 and SEBB benefits stop on August 31st.
- If an employee retires on July 1st they will be eligible for the DRS COLA the following July 1st.
- If an employee retires on September 1st, they are not eligible for COLA the next July, as they have not been retired one year. The COLA they missed gets banked for future use.

Interested in learning more about National Board Certification?

National Board (NB) Certification is the highest credential in the teaching profession and is a voluntary process established by the National Board for Professional Teaching Standards (NBPTS). Achieving certification is a challenging but flexible 1–5 year process, during which LWSD teachers, librarians, and counselors can participate in free Cohort support with trained NB Facilitators. The LWSD NB Cohort for those working on NB during the 2023–2024 school year begins in June.

This spring there are two information sessions on Teams to introduce the NB requirements, process, timelines, options, cost, benefits, and other logistics. We will also familiarize you with the support that LWSD provides to those working on NB certification. These information sessions will be hosted by Julia Vasiliauskas and Danielle Lankester, the current LWSD NB facilitators.

Retirement Savings Options

In addition to your state pension plans, the district offers two other ways to save for retirement. DCP Plans and 403(b) Plans. DCP Plans are provided through DRS and 403(b) are provided through a third-party administrator called Envoy. To learn more about these plans and how to sign up, please visit the Payroll & Benefits page on the Staff Portal.

Historically, 403(b) vendors received approval from building administrators for on-campus information sessions promoting their services. It has been up to each administrator whether they allowed a visit or not. This has created multiple challenges with consistency between buildings and has led some employees to believe that the district endorses those 403(b) vendors that visit campus. Too often, the vendors that attempt to schedule visits have comparatively higher fees for their services. For these reasons, the District's Benefit Advisory Committee is recommending that **schools no longer allow vendors on campus to promote 403(b) plans.** If you would like to schedule a meeting with a 403(b) representative, this should be done during personal time and preferably off campus.
