## **WA Cares Act - Long Term Care** Begins Again July 1, 2023



The WA Cares Act, passed by the legislature, mandates long term care benefits for Washington state residents, which will be funded by premiums collected from employee's wages. On January 27, 2022, the Governor signed house bill (HB) 1732 delaying the collection of the Washington Cares Fund premiums until July 1, 2023. Beginning in July 2023, employers must deduct 0.58% (or \$0.58 per \$100) of employees' wages to fund the new State Long Term Care Program.

Beginning in July 2026, each person who is eligible to receive the benefit can access services and supports costing up to \$36,500 (maximum lifetime benefit). To be eligible to receive the benefit you must meet certain qualifications. To learn more about the contributions, benefits, eligibility, and timelines, please visit: WA Cares Fund

Employees who have private long term care insurance plans established before November 1, 2021, had a one-time opportunity to apply for a lifetime exemption from this payroll tax. Exemptions must have been applied for between October 1, 2021, and December 31, 2022.

If you are new to the district and have not turned in your exemption letter, please email a copy to Shelly Fanning at sfanning@lwsd.org. If you turned in your exemption letter prior to January 31, 2022, you do not need to resubmit your letter.
